# Award Fund Cover page

The Trustees of the Edward N. Sands Fund would like to encourage those who feel they have financial need to complete the attached form.

The following information needs to be understood <u>prior</u> to completing this form:

- 1. Applicant must be a graduate of Liberty Union High School and a resident of the Liberty Union-Thurston School District for at least 3 years prior to their first application.
- 2. Applicants must be attending an Ohio Tax-supported Institution of Higher Learning as defined by the Ohio Department of High Education (formerly known as the Ohio Board of Regency). (List available from Sands Scholarship Committee member or the high school guidance office.) The Committee will also take into consideration applicants attending school for advanced training in a skilled trade or vocation that is accredited.
- 3. All information requested must be provided in order for the application to be considered.
- 4. Self-supporting applicants who are graduates of Liberty Union-Thurston High School and have met the residency requirements in item # 1 may apply if they are planning to enroll in an approved college, university, or trade/vocational school. A self-supporting applicant is defined as one providing for all their financial needs and **not** residing in their parents' or guardians' home.
- 5. Those applicants approved for financial aid will be reimbursed <u>following</u> <u>completion</u> of each semester. Tuition reimbursement will be given only for courses in which they receive a "C" or better final grade. An original grade slip (NO PHOTOCOPIES) must be presented for payment. Pass/ Fail courses will not be accepted for reimbursement without prior approval of the Sands Fund Committee. A copy of the current paid fee statement will also be needed.

- 6. Those taking 12 or more hours **may** receive a maximum of \$3,000 per semester depending on total award amount. Qualifying applicants who attend school on a part-time basis, less than 12 semester hours, may be reimbursed on a per semester hour basis. The semester hour rate will not exceed \$250 per hour. Applicants may be considered for partial reimbursement based upon financial need or other financial assistance considerations. A separate pro-rated, per-semester-hour amount will apply in these partial funding situations.
- 7. Scholarships awarded are for one year only. Applicants must re-apply for financial assistance each year. No applicant will be funded for more than 5 years on an undergraduate degree program. The deadline is **April 1st, 2024,** to submit applications for the following fall semester.
- 8. Those on graduate degree programs will not be considered for a Sands Fund Scholarship.
- 9. The Sands Fund Committee reserves the right to change and/or modify the stated rules by committee vote to cover unforeseen financial or other issues not anticipated when these guidelines were updated.
