# Fairfield County COVID-19 Relief Fund Continues to Support Non-Profits Affected by Pandemic

LANCASTER, Ohio – Nonprofits in Fairfield County can take action to alleviate some of the financial burdens brought on by the coronavirus pandemic by applying for funds from the COVID-19 Relief Fund, established in April by the Fairfield County Foundation (FCF) and United Way of Fairfield County's (UWFC). Since its inception, the fund has provided grants to 22 local nonprofits impacted by the pandemic. Area nonprofits should submit an application for consideration in the next round of funding now through July 10th. Awards will be made on July 15, 2020.

"While many businesses have returned to or resumed operations, the challenges resulting from COVID-19 continue to impact many organizations," said Amy Eyman, Fairfield County Foundation Executive Director. "We have provided more than \$64,000 in grants to 22 nonprofits through the COVID-19 Relief Fund. Funding has ranged from PPE and cleaning supplies, to shelter and food needs, and more. Our nonprofit needs are diverse, and with the flexible giving opportunities that COVID-19 Relief Fund provides, we are able to address those needs so the nonprofits can do what they do best."

To date, the COVID-19 Relief Fund has awarded grants to the following nonprofits:

- Fairfield County TeenWorks Laser thermometer, masks, hand sanitizer and wipes

- Lancaster Fairfield Community Action Agency Commercial upright freezer for increased need
- Robert K Fox Family YMCA Childcare cost/needs due to reduced ratio Sanderson location
- St. Vincent de Paul Society Increased demand for food boxes
- Sozo Pediatrics Cleaning supplies and PPE
