of this community. But we know that the financial needs will be significant for many local non-profits. In the coming weeks and months, the Foundation staff and Board of Trustees will develop a plan that will utilize our Community Impact Fund to provide resources that address the needs of a variety of local causes and non-profit partners."

The Community Impact Fund, established in 2019, is an unrestricted fund that will allow the Foundation to respond to changing community needs, support innovative solutions for community problems and enhance the quality of life in Fairfield County. Gifts made to the fund will be part of an endowment dedicated in perpetuity to Fairfield County's well-being, benefitting current residents and generations to come.
