Below is a complete listing of the Cycle 2 grant recipients:

Terry A. McGhee/Sally J. Grimm Community Fund

By The Way Free Clinic – Technology upgrades and improved medical equipment/supplies including: AED batteries, blood pressure monitor and diabetic glucometer test strips.

Wendel Family Fund

Community Kitchen – Dishwasher replacement to support the organization in providing free meals to those in need.

Patricia A. Beam Fund

Frontier Players Association – Public address system, banners, marketing support and other items to enhance the experience for children in attendance.

Jerry and Janet Nauman Foundation Fund

Hardbarger Impact Ministries – Vehicle lift, tool set and tool chest for God's Garage, which provides free vehicle maintenance for those in need.

George and Dollie L. Zimpfer Memorial Fund

Lancaster-Fairfield Community Action – Installation of new windows and doors in the administrative area as part of a larger project to replace the building's HVAC system for improved energy efficiency.

Robert A. Schatz Fund

Lancaster Recovery Services – Offsetting workbook costs and fees for entry into substance abuse disorder out-patient treatment.

- Preliminary Grants: Due second Monday in September September 9, 2019
- Invitations to submit full grant sent second week of September
- Grant Application: Due second Monday of October October 14, 2019
- Grant Committee recommendations to Board of Trustees for approval November 21, 2019
